Sunday at 8:30pm on reflector 77A. This is a Nashville net. Then switch over to Nashville analog repeater at 9pm for the FM net.

Tuesday at 7:30 on reflector 48B. I believe this is a Little Rock net. There has been couple of local operators check in.

You may use a dongle or change the 4SARC club D-Star repeater to any reflector. Keep in mind, that after 15 minutes of no key up, the club D Star repeater will change automatically to reflector 1C. So, just key up about 14 minutes!



Membership Renewal

You may now renew your membership for \$20 on the website via PayPal. After paying, please verify the expiration date of January 31, **2022**. Since the club is not meeting due to Covid, this is the simplest way to join or renew.

You may pay by Paypal, Check or by credit /debit card from the website. You do not need a Paypal account to pay online.

If you are a NEW member, click on Register at the top of the page, then Select for FSARC Membership.

If you are RENEWING your current membership or changing Membership Level (Newsletter to Dues paying), it is easy to. Login as you normally do, then goto Members Only / Membership Account Detail / My Memberships / Renew or Change.

If you do not have a Paypal account, once the website transfers you to Paypal.com, scroll further down the page and to "Pay with a debit or credit card".

VERY IMPORTANT STEP!! After the Paypal redirects you back to the club website, make sure you scroll to the bottom of the page and click on Complete Processing. If this step is skipped, your membership will not be completed.


